Your company and you MUST be a NEW overseas industry buyer, i.e. your company or yourself have not visited the Hong Kong Watch & Clock Fair 2015 (W&C 2015) or SALON DE TE 2015, and will attend Watch & Clock Fair 2016 (W&C 2016) and SALON DE TE 2016, in order to be eligible for the Travel Reimbursement Programme.
2. Hong Kong Watch & Clock Fair 2016 (W&C 2016) and SALON DE TE 2016 are open for business visitors 18 years old or above only.
3. Your company MUST NOT be an EXHIBITOR of W&C 2016, SALON DE TE 2016 or the concurrent fair CENTRESTAGE.
4. If your company or you have applied for Hotel Sponsorship, Air + Hotel Package, Travel Reimbursement or other buyer sponsorship programmes of W&C Fair 2016, SALON DE TE 2016 or the concurrent fair CENTRESTAGE, applications for this sponsorship will not be processed.
5. Each company is entitled to ONLY ONE OFFER OF TRAVEL REIMBURSEMENT. This offer is available on a first-come-first-served basis.
6. Applications without attaching a photocopy of the applicant's business card will not be processed. Your company information must be identical to the information on your application form.
7. Once your application has been approved, we will send the acknowledgement letter to you within 4 working days.
8. Successful applicants must show up in the fair and complete a questionnaire when collecting the reimbursement at the "Buying Mission Service Counter" in the fairground.
9. You must visit the fair and collect three customized stamps from the "Buying Mission Service Counter" in order to qualify for the incentive. **Only one stamp can be collected on each fair day.**
10. **The original copy of acknowledgement letter, passport with landing slip, business card, boarding pass and e-ticket receipt MUST BE presented upon the reimbursement collection. HKTDC reserves the right to reject any reimbursement requests should there be any informational discrepancies on the passport, landing slip, boarding pass and e-ticket receipt.**
11. HKTDC reserves the rights to vary the terms and conditions, change or terminate the sponsorship programme without any prior notice. In case of any dispute over the programme, the decision of HKTDC shall be final and binding.
