- 4. Successful applicants (exhibitors) are required to submit selected watch(es) to HKTDC onsite according to the collection time assigned.

- a. Dully completed REPLY SLIP
- b. **PRODUCT INFORMATION** including item name / model number, retail value as well as description (e.g. limited edition, unique selling points, etc.)
- c. **PHOTOS** (or image files) of nominated watch(es) and company logo via email (for checking and record purpose only) (resolution: minimum 300 dpi / Format: .jpg / Images should show watches clearly)

**Late submission WILL NOT be accepted.** Please also note that not all submissions will be selected for the parades. It is important that you provide sufficient information requested above for HKTDC to process your application. HKTDC reserves full discretion in selecting suitable watch items according to the parade themes and onsite arrangement.
