3. Exhibitors of HKTDC Hong Kong Watch & Clock Fair and Salon de TIME 2026 are not eligible for the hotel sponsorship programme.
4. The Hotel Sponsorship is offered to **Pre-approved overseas trade buyers** only.
5. If your company or you have applied for the Travel Reimbursement Programme or any other buyer sponsorship programmes of concurrent fair, this application will not be processed.
6. Once your application has been approved, the hotel will request your credit card information to guarantee your room reservation. If you fail to provide this information or do not follow the hotel's guidelines, the hotel reserves the right to cancel your booking. HKTDC will not be held responsible for any resulting issues.
7. HKTDC will not collect your credit card information for hotel reservation or guarantee your stay.
8. Each company is entitled to only one room at one hotel from 31 August – 5 September 2026 (inclusive). This offer is available on a first come, first served basis and subject to room availability.
9. If your company information is not the same as on the hotel sponsorship application form; or the company information provided is incorrect, HKTDC reserves the rights to void this sponsorship without prior notice. All hotel charges will be settled on your account.
10. Your company information and personal particulars must be identical to the information on your application form, business card and passport.
11. You must show up at the HKTDC Hong Kong Watch & Clock Fair and Salon de TIME 2026 and complete a buyer survey when collecting the Hotel Sponsorship Voucher at the "Buying Mission Service Counter". The person collecting the Hotel Voucher and the stamps must be the same person applying for this programme.

12. Hotel will levy penalty charge on your credit card if you do not show up on the specified date.
 13. If the choice of hotel is fully booked, HKTDC will designate a hotel to the applicant.
 14. Applications without attaching a photocopy of the applicant's business card will not be processed.
 15. Your application is subject to review by HKTDC. Once your application has been approved, we will send the acknowledgement letter to you within 5 working days.
 16. The original copy of acknowledgement letter, passport with landing slip, business card, boarding pass and e-ticket receipt MUST BE presented upon the Voucher collection. The HKTDC reserves the right to reject any reimbursement requests should there be any informational discrepancies on the passport, landing slip, boarding pass and e-ticket receipt.
 17. The HKTDC reserves the rights to vary the terms and conditions, change or terminate the sponsorship programme without any prior notice. In case of any dispute over the programme, the decision of HKTDC shall be final and binding.
